3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT  
6 WITH LCPTRACKER, INC. TO PURCHASE CERTIFIED  
7 PAYROLL REPORTING AND LABOR COMPLIANCE  
8 MONITORING SOFTWARE, AND AS-NEEDED SUPPORT,  
9 ON THE SAME TERMS AND CONDITIONS AFFORDED  
10 THROUGH THE GENERAL SERVICES ADMINISTRATION  
11 (GSA) CONTRACT, IN AN ANNUAL AMOUNT NOT TO  
12 EXCEED \$55,000, UNTIL THE GSA CONTRACT EXPIRES  
13 ON MAY 7, 2024, WITH THE OPTION TO RENEW FOR AS  
14 LONG AS THE GSA CONTRACT IS IN EFFECT, AT THE  
15 DISCRETION OF THE CITY MANAGER

17 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the  
18 City to purchase services, supplies, materials, equipment and labor with other government  
19 agencies by purchasing under their contracts on a voluntary and selective basis when  
20 authorized by resolution; and

21 WHEREAS, the City desires to purchase certified payroll reporting and labor  
22 compliance monitoring software, and as-needed support; and

23 WHEREAS, General Services Administration has a Contract for the purchase  
24 of these certified payroll reporting and labor compliance monitoring software, Contract No.  
25 GS-35F-364BA ("GSA"); and

26 WHEREAS, the City's participation in the GSA Contract will facilitate the  
27 City's ability to purchase as well as provide considerable cost benefits to the City; and

28 WHEREAS, if the City had to utilize a formal bid process rather than

1 participate in the GSA Contract considerably more funds would be required;

2 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
3 follows:

4 Section 1. The above recitals are true and correct and are incorporated  
5 herein by this reference.

6 Section 2. The City Manager or designee is hereby authorized to enter an  
7 agreement with LCPtracker, Inc. to purchase certified payroll reporting and labor  
8 compliance monitoring software, and as-needed support, of the same type and kind  
9 identified in the General Services Administration Contract except as modified by mutual  
10 agreement of the City and LCPtracker, Inc., and the purchase by the City shall be on the  
11 same terms and conditions afforded to General Services Administration in an amount not  
12 to exceed Fifty-Five Thousand Dollars (\$55,000), until the General Services Administration  
13 contract expires on May 7, 2024, with the option to renew for as long as the General  
14 Services Administration contract is in effect, at the discretion of the City Manager.

15 Section 3. This resolution shall take effect immediately upon its adoption  
16 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
