3 ~~THIS FIRST AMENDMENT TO CONTRACT NO. 36105 is made and~~
4 entered, as of September 21, 2022, for reference purposes only, pursuant to Resolution
5 No. RES-22-0164, adopted by the City Council of the City of Long Beach at its meeting
6 on September 13, 2022, by and between MCNEILUS FINANCIAL, INC., DBA
7 MCNEILUS TRUCK AND MANUFACTURING, a Texas corporation ("Contractor"), with a
8 place of business at 524 E. Highway Street, Dodge Center, MN, 55927, and the CITY OF
9 LONG BEACH ("City"), a municipal corporation.

10 WHEREAS, City and Contractor ("Parties") entered into Contract No. 36105
11 (the "Contract") whereby Contractor provided as needed McNeilus refuse truck parts; and

12 WHEREAS, the Parties desire to amend the Contract to increase the
13 annual not to exceed amount by \$115,000;

14 NOW, THEREFORE, in consideration of the mutual terms and conditions
15 contained herein, the Parties agree as follows:

16 1. Section 2 of the Contract is hereby amended to read as follows:

17 "2. City shall pay Contractor in due course of payments, following
18 receipt of an invoice from Contractor and upon acceptance from City, for the Parts at the
19 prices shown in Exhibit "A," for an annual contract amount for the term May 11, 2021, to
20 May 10, 2022, One Hundred Thousand Dollars (\$100,000), with a contingency of Fifteen
21 Thousand (\$15,000), for a total amount not to exceed One Hundred Fifteen Thousand
22 Dollars (\$115,000); and, for the term May 11, 2022, to May 10, 2023, City shall pay
23 Contractor an annual contract amount of Two Hundred Fifteen Thousand Dollars
24 (\$215,000), with a fifteen percent (15%) contingency of Thirty Two Thousand Two
25 Hundred Fifty Dollars (\$32,500), for a revised total annual amount not to exceed Two
26 Hundred Forty Seven Thousand Fifty Dollars (\$247,250.00)."

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Contract No. 36105 are ratified and confirmed and shall remain in full force
