THIS FIRST AMENDMENT TO CONTRACT NO. 36105 is made and entered, as of September 21, 2022, for reference purposes only, pursuant to Resolution No. RES-22-0164, adopted by the City Council of the City of Long Beach at its meeting on September 13, 2022, by and between MCNEILUS FINANCIAL, INC., DBA MCNEILUS TRUCK AND MANUFACTURING, a Texas corporation ("Contractor"), with a place of business at 524 E. Highway Street, Dodge Center, MN, 55927, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor ("Parties") entered into Contract No. 36105 (the "Contract") whereby Contractor provided as needed McNeilus refuse truck parts; and WHEREAS, the Parties desire to amend the Contract to increase the annual not to exceed amount by \$115,000;

City shall pay Contractor in due course of payments, following receipt of an invoice from Contractor and upon acceptance from City, for the Parts at the prices shown in Exhibit "A," for an annual contract amount for the term May 11, 2021, to May 10, 2022, One Hundred Thousand Dollars (\$100,000), with a contingency of Fifteen Thousand (\$15,000), for a total amount not to exceed One Hundred Fifteen Thousand Dollars (\$115,000); and, for the term May 11, 2022, to May 10, 2023, City shall pay Contractor an annual contract amount of Two Hundred Fifteen Thousand Dollars (\$215,000), with a fifteen percent (15%) contingency of Thirty Two Thousand Two Hundred Fifty Dollars (\$32,500), for a revised total annual amount not to exceed Two Hundred Forty Seven Thousand Fifty Dollars (\$247,250.00)."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Contract No. 36105 are ratified and confirmed and shall remain in full force
