THIRD AMENDMENT TO AGREEMENT NO. 33774

THIS THIRD AMENDMENT TO AGREEMENT NO. 33774 is made and entered, in duplicate, as of October 26, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 6, 2015, by and between CSG CONSULTANTS, INC., a California corporation ("Consultant"), with a place of business at 550 Pilgrim Drive, Foster City, California 94404, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspection services; and

WHEREAS, City and Consultant entered into Agreement No. 33774 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, City and Consultant entered into a First Amendment to the Agreement to increase the Agreement amount by \$50,000; and

WHEREAS, City and Consultant entered into a Second Amendment to the Agreement to increase the Agreement amount by \$60,000; and

WHEREAS, City and Consultant desire to increase the Agreement amount by \$20,000 for a total not to exceed amount of \$160,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "1. SCOPE OF WORK OR SERVICES.
- A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, an amount not to exceed One Hundred Sixty Thousand Dollars (\$160,000), at the rates or charges shown in Exhibit "B"."
