

1 FIRST AMENDMENT TO AGREEMENT NO. 35854

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35854 is made and  
4 entered, in duplicate, as of July 8, 2021, for reference purposes only, pursuant to a minute  
5 order adopted by the City Council of the City of Long Beach at its meeting on June 9, 2020,  
6 by and between TALENT & ACQUISITION LLC, dba STAND 8, a California limited liability  
7 company ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

8 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
9 35854 (the "Agreement") whereby Consultant agreed to provide on-call professional and  
10 technical services for system analysis, development, implementation, project  
11 management, and technical support for information technology projects and systems; and

12 WHEREAS, the Parties desire to increase the amount of the agreement.

13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
14 conditions herein contained, the Parties agree as follows:

15 1. Section 1.A of the Agreement is hereby amended to read as follows:

16 1. SCOPE OF WORK OR SERVICES.

17 A. Consultant shall furnish specialized services more particularly  
18 described in Exhibit "A", attached to this Agreement and incorporated by this  
19 reference, in accordance with the standards of the profession, and City shall pay for  
20 these services in the manner described below, in an annual amount not to exceed  
21 Four Hundred Thousand Dollars (\$400,000), at the rates or charges shown in  
22 Exhibit "B".

23 2. Except as expressly modified herein, all of the terms and conditions  
24 contained in Agreement No. 35854 are ratified and confirmed and shall remain in full force  
25 and effect.
