3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT WITH
6 ROTORCRAFT SUPPORT INCORPORATED, WITHOUT
7 ADVERTISING FOR BIDS, FOR FURNISHING PARTS AND
8 SERVICE FOR AMERICAN EUROCOPTER EC-130
9 HELICOPTERS FOR ONE YEAR IN THE ESTIMATED SUM
10 OF \$500,000 AND WITH OPTIONS TO EXTEND FOR TWO
11 ADDITIONAL YEARS

13 WHEREAS, City now owns American Eurocopter EC-130 helicopters; and
14 WHEREAS, in the maintenance of the helicopters, City will need replacement
15 parts and service for their repair; and

16 WHEREAS, Rotorcraft Support Incorporated is the sole West Coast
17 factory-authorized distributor for replacement parts and repair of the helicopters; and

18 WHEREAS, no useful purpose would be served by advertising for bids for
19 furnishing and delivering replacement parts and to do so would constitute an idle and
20 useless act and an unnecessary expenditure of public funds because Rotorcraft
21 Support, Inc. is the only corporation, firm or individual that could or would bid for the
22 furnishing of replacement parts and repair to the City;

23 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
24 follows:

25 Section 1. That the City Manager be and he is hereby authorized to enter a
26 contract with Rotorcraft Support Incorporated for the purchase of replacement parts and
27 repair of the American Eurocopter EC-130 helicopters as may be required by the City for
28 a period of one year in a sum not to exceed \$500,000 annually without advertising for bids.

1 The parties may, by mutual agreement, extend the term for two additional periods of one
2 year each. Up to ten percent (10%) of the annual amount may be spent annually for
3 additional purchases. If the sole source status of Rotorcraft Support, Inc. changes, City
4 shall publicly bid instead of extending the agreement.

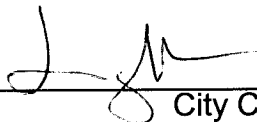
5 Sec. 2. This Resolution shall take effect immediately on its adoption by the
