THIS SECOND AMENDMENT TO AGREEMENT NO. 35397 is made and entered, as of May 17, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 20, 2019, by and between GLENN A. RICK ENGINEERING AND DEVELOPMENT CO. dba RICK ENGINEERING COMPANY, a California corporation ("Consultant"), with a place of business at 5620 Friars Road, San Diego, California 92110, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35397 (the "Agreement") whereby Consultant agreed to provide as-needed, on-call consulting services for street design projects in an amount not to exceed One Million Dollars (\$1,000,000) for a period of three (3) years with the option to extend for two (2) additional one-year periods; and

WHEREAS, the Parties entered into a First Amendment to extend the term of the Agreement to September 30, 2023, attach an updated rate sheet, and update the City Representative; and

WHEREAS, the Parties desire to extend the term of the Agreement using the final one-year period option, and attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on October 1, 2019, and shall terminate at 11:59 p.m. on September 30, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. The Rates in Exhibit "B-1" in the First Amendment to the Agreement are hereby amended in accordance with Exhibit "B-2", attached hereto and incorporated
