

THIRD AMENDMENT TO AGREEMENT NO. 33387

33387

THIS THIRD AMENDMENT TO AGREEMENT NO. 33387 is made and entered, in duplicate, as of March 1, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 3, 2015, by and between APOLLO PROFESSIONAL SOLUTIONS, a Massachusetts corporation, with a branch located at 4010 Watson Plaza Dr., Suite 138, Lakewood, California 90712 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed on an as-needed basis in connection with professional and technical services for information technology projects and systems; and

WHEREAS, the parties entered Agreement No. 33387 whereby Consultant agreed to provide these services; and

WHEREAS, the parties desire to increase the total not to exceed contract amount;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Amendment, the parties agree as follows:

1. Section 1.A of Agreement No. 33387 is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, a total not to exceed contract amount of Six Hundred Thousand Dollars (\$600,000), at the rates or charges shown in Exhibit "A"."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33387 are ratified and confirmed and shall remain in full
