# **RECOMMENDATION:**

Declare ordinance amending the Departmental Organization Ordinance read the first time and laid over to the next regular meeting of the City Council for final reading. (Citywide)

## **DISCUSSION**

The attached amendment to Ordinance C-6496, relating to the departmental organization of the City of Long Beach, incorporates changes to departments, bureaus, and divisions as listed on the attached summary for Fiscal Year 2008 (FY 08). These organizational changes are necessary to address emergent operational needs that have arisen since the adoption of the FY 08 Budget. These changes include changing the Planning and Building Department to the Development Services Department, reorganizing the Public Works Department and creating a separate department for the Long Beach Airport.

This item was reviewed by Deputy City Attorney Christina L. Checel on June 20, 2008, and by Budget Management Officer Victoria Bell on June 18, 2008.

## TIMING CONSIDERATIONS

City Council approval of the amended Departmental Organization Ordinance is requested on July 8, 2008, to ensure timely implementation of requested organizational changes.
