1 FIRST AMENDMENT TO AGREEMENT NO. 36087

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 36087 is made and
4 entered, in duplicate, as of April 6, 2022 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on July 6, 2021,
6 by and between MICHAEL BAKER INTERNATIONAL, INC., a Pennsylvania corporation
7 ("Consultant"), with a place of business at 3760 Kilroy Airport Way, Suite 270, Long Beach,
8 California 90806, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 36087 (the "Agreement") whereby Consultant agreed to provide as-needed professional
11 engineering services; and

12 WHEREAS, the Parties desire to add \$1,000,000 for a total not to exceed
13 amount of \$4,500,000;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 1.A. of the Agreement is hereby amended to read as follows:

17 "A. Consultant shall furnish specialized services more particularly
18 described in Exhibit "A", attached to the Agreement and incorporated by this
19 reference, in accordance with the standards of the profession, and City shall pay for
20 these services in the manner described below, in an amount not to exceed Four
21 Million Five Hundred Thousand Dollars (\$4,500,000), at the rates or charges shown
22 in Exhibit "B"."

23 2. Except as expressly amended herein, all terms and conditions in
24 Agreement No. 36087 are ratified and confirmed and shall remain in full force and effect.
