1 **THIRD AMENDMENT TO CLINICAL AFFILIATION AGREEMENT NO. 26058**
2 **26058**

3 This Third Amendment to Agreement No. 26058 is authorized pursuant to a
4 minute order adopted by the City Council of the City of Long Beach at its meeting held on
5 November 14, 2006, between LONG BEACH MEMORIAL MEDICAL CENTER (hereinafter
6 "LBMMC"), and the CITY OF LONG BEACH (hereinafter "City"), collectively referred to as
7 the "parties."

8 WHEREAS, the City provides approved programs in health care education
9 including, but not limited to, EMT-I and EMT-Paramedic training, which requires clinical
10 experience for participants enrolled in these programs; and

11 WHEREAS, LBMMC owns and operates as acute care hospital and ancillary
12 facilities that are appropriate for furnishing such experience; and

13 WHEREAS, it has mutually benefitted LBMMC and City to allow the
14 employees and students of City's program to use LBMMC facilities for their field
15 experience; and

16 WHEREAS, the parties now desire to amend Agreement No. 26058 to extend
17 the term.

18 NOW, THEREFORE, it is agreed as follows:

19 1. Section 6 of Agreement No. 26058 is hereby amended in its entirety
20 to read as follows:

21 **"6. TERM; TERMINATION.**

22 This Agreement is for a term of two (2) years commencing on January 1,
23 2007 and it may be renewed for an additional two (2) years subject to the approval
24 of LBMMC and the City Manager of Long Beach.

25 This Agreement may be terminated by either party, acting with or without
26 cause by giving written notice of termination thirty (30) days prior to the end of a
27 semester."

28 2. Except as expressly amended herein, all terms and conditions in
