3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO EXECUTE AN AGREEMENT WITH  
6 ARIZONA MACHINERY, INC. DBA STOTZ EQUIPMENT, A  
7 LOCAL DISTRIBUTOR FOR JOHN DEERE  
8 CONSTRUCTION RETAIL SALES, OF MOLINE, IL, FOR  
9 THE PURCHASE OF TWO JOHN DEERE TRACTORS,  
10 WITH RELATED EQUIPMENT AND ACCESSORIES, ON  
11 THE SAME TERMS AND CONDITIONS AFFORDED TO  
12 SOURCEWELL (FORMERLY THE NATIONAL JOINT  
13 POWER ALLIANCE) IN A TOTAL AMOUNT NOT TO  
14 EXCEED \$536,579

16 WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802,  
17 permits the City to purchase services, supplies, materials, equipment and labor with other  
18 government agencies by purchasing under their contracts on a voluntary and selective  
19 basis when authorized by resolution; and

20 WHEREAS, the City desires to purchase two John Deere tractors, with  
21 related equipment, (1) current model John Deere 7R210 tractor to replace existing unit  
22 (14809) and (2) current model John Deere 6R215 tractor to replace existing unit (143007),  
23 for use by the Department of Parks, Recreation and Marine, Beach Maintenance Division,  
24 to provide critical support for the maintenance of the City of Long Beach beaches,  
25 especially during storm season when large amounts of debris and sand need to be  
26 removed; and

27 WHEREAS, Sourcewell (formerly the National Joint Power Alliance) entered  
28 into Sourcewell Contract Number 032119-JDC with John Deere Construction Retail Sales

1 which provides the best value to the City for the purchase of two John Deere tractors, with  
2 related equipment and accessories ("Sourcewell Contract"); and

3 WHEREAS, Arizona Machinery, Inc. dba Stotz Equipment is a local  
4 distributor of John Deere Construction Retail Sales; and

5 WHEREAS, the City's participation in the Sourcewell Contract will facilitate  
6 the City's ability to purchase as well as provide considerable cost benefits to the City; and

7 WHEREAS, if the City had to utilize a formal bid process rather than  
8 participate in the Sourcewell Contract, considerably more funds would be required;

9 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
10 follows:

11 Section 1. The above recitals are true and correct and are incorporated  
12 herein by this reference.

13 Section 2. The City Manager or designee is hereby authorized to enter an  
14 agreement with Arizona Machinery, Inc. dba Stotz Equipment, for the purchase of two John  
15 Deere tractors with related equipment and accessories, of the same type and kind identified  
16 in the Sourcewell Contract except as modified by mutual agreement of the City and Arizona  
17 Machinery, Inc. dba Stotz Equipment, and the purchase by the City shall be on the same  
18 terms and conditions afforded to the Sourcewell in an amount not to exceed Five Hundred  
19 Thirty-Six Thousand Five Hundred Seventy-Nine Dollars (\$536,579) including taxes and  
20 fees.

21 Section 3. This resolution shall take effect immediately upon its adoption  
22 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
