

1 SECOND AMENDMENT TO AGREEMENT NO. 33446

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 33446 is made and
4 entered, in duplicate, as of March 15, 2017 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on March
6 18, 2014, by and between ATKINS NORTH AMERICA, INC., a Florida corporation, with a
7 place of business at 625 The City Drive, Suite 200, Orange, California 92868
8 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with on-call street design consulting services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
12 33446 (the "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 update the City representative and extend the term an additional one (1) year period; and

15 WHEREAS, the Parties desire to decrease the Agreement by \$600,000 for a
16 total not to exceed amount of \$400,000;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions herein contained, the parties agree as follows:

19 1. Section 1.A of the Agreement is hereby amended to read as follows.

20 "A. Consultant shall furnish specialized services more particularly
21 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
22 accordance with the standards of the profession, and City shall pay for these services in
23 the manner described below, not to exceed Four Hundred Thousand Dollars (\$400,000),
24 at the rates or charges shown in Exhibit "B"."

25 2. Except as expressly modified herein, all of the terms and conditions
26 contained in Agreement No. 33446 are ratified and confirmed and shall remain in full force
27 and effect.
