As a part of the public safety continuum, it is necessary for dispatch staff to work overtime hours to support continuous operation of the City's public safety response, along with Police and Fire.



Clinician in Jail Pilot

August 2018 Update

The Clinician in Jail Pilot is a partnership between the Long Beach Police Department and The Guidance Center to provide the Long Beach Jail with a mental health professional to assess, connect, and divert individuals to mental health care. The pilot places a full-time mental health clinician in the jail to conduct pre-release assessment and treatment planning for individuals who are in police custody. The clinician also participates in the City's newly established Multi-Disciplinary Team (MDT) that provides care coordination. Now in its fifth month, the Clinician has made a total of 277 contacts from April - July 2018 with individuals in jail. From the total contacts seen, 33% have been given a pre-release plan and 21% have had a biopsychosocial assessment conducted. Since the start of the pilot the clinician has been able to increase her capacity from 37 contacts in April to an astonishing 98 contacts in July.



About the Justice Lab

The City launched the Justice Lab in January 2018 to provide new tools to first responders to divert residents in need out of the criminal justice system and towards much-needed resources like treatment and care. The Justice Lab, incubated in the City's Innovation Team (i-team), conducted a people-focused and data-driven analysis of individuals who had multiple contacts with the City's criminal justice system in 2017. After analyzing over 100,000 offenses in Long Beach during a five-year period, the i-team determined that 85% of repeat offenses are not serious crimes, but rather low-level misdemeanor crimes. The team conducted 26 in-depth interviews with people who had 11 or more citations and arrests. Additionally, the i-team spoke with over 21 subject matter experts, participated in over 12 observational visits, and engaged over 65 participants help co-create the Justice Lab's initiatives.
