SECOND AMENDMENT TO AGREEMENT

THIS SECOND AMENDMENT TO AGREEMENT is made and entered, in duplicate, as of August 18, 2020 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 4, 2020, by and between LA GUANAQUITA RESTAURANT, LLC, DBA LA GUANAQUITA RESTAURANT, a California limited liability company ("Contractor"), with a place of business at 5344 Long Beach Blvd., Long Beach, CA 90805, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement ("Agreement") whereby Contractor agreed to provide the specialized services as described in Request for Proposals Number CM20-058; and

WHEREAS, the Parties desire to extend the term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2. of Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on June 11, 2020, and shall terminate at 11:59 p.m. on September 11, 2020, with the option to renew for one (1) additional one month period based on program extensions from the state, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in this Agreement are ratified and confirmed and shall remain in full force and effect.
