## SECOND AMENDMENT TO CONTRACT NO. 33980

THIS SECOND AMENDMENT TO CONTRACT NO. 33980 ("Second Amendment") is made and entered, in duplicate, as of December 1, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on June 2, 2015, by and between UNITED CAMBODIAN COMMUNITY, a non-profit Corporation ("Contractor") with offices located at 2201 E. Anaheim Street, Suite 200, Long Beach, California 90804, and the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for Pacific Gateway Workforce Investment Network.

WHEREAS, City requires specialized services requiring unique skills to be performed in providing Workforce Investment Act/Workforce Innovation and Opportunity Act (WIA/WIOA) program services to out-of-school youth; and

WHEREAS, City and Contractor entered into Contract No. 33980 (the "Contract") whereby Contractor agreed to provide such services; and

WHEREAS, City and Contractor entered into a First Amendment to the Contract to extend the term and increase the not to exceed amount; and

WHEREAS, City and Contractor desire to add \$20,000 for a total not to exceed contract amount of \$393,155;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract and in this Amendment, the parties agree as follows:

1. The first paragraph to Section 5 of the Contract is hereby amended to read as follows:

## "SECTION 5. CONTRACT AMOUNT AND PAYMENT.

The total amount which shall be payable by City to Contractor for Contractor's allowable services during the term shall not exceed Three Hundred Ninety-Three Thousand One Hundred Fifty-Five Dollars (\$393,155)."

Except as expressly amended in this Second Amendment, all terms
