4 entered, in duplicate, as of August 13, 2019, for reference purposes only, by and between  
5 BDO USA, LLP formerly CASTERLINE ASSOCIATES PC, a Delaware limited liability  
6 partnership, whose address is 1801 Market Street, Suite 1700, Philadelphia, Pennsylvania  
7 19103 ("Contractor"), and the HOUSING AUTHORITY OF THE CITY OF LONG BEACH,  
8 a public body ("City").

9 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.  
10 34756 whereby Contractor agreed to provide comprehensive accounting services; and

11 WHEREAS, the Parties desire to exercise their option to extend the term of  
12 Agreement No. 34756 one (1) additional one-year period;

13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
14 conditions in here contained, the Parties agree as follows:

15 1. Section 2 of Agreement No. 34756 is hereby amended to read as  
16 follows:

17 "2. TERM. The term of this Agreement shall commence at midnight on  
18 October 1, 2017, and shall terminate at 11:59 p.m. on September 30, 2020, unless sooner  
19 terminated as provided in this Agreement, or unless the services or the Project is  
20 completed sooner."

21 2. Except as expressly amended herein, all terms and conditions in  
22 Agreement No. 34756 are ratified and confirmed and shall remain in full force and effect.
