DISCUSSION

Attached are the Resolutions prepared by the City Attorney on the results of the consolidated City of Long Beach Primary Nominating Election held on Tuesday, June 7, 2022:

1. A Resolution of the City Council of the City of Long Beach declaring the results of the Primary Nominating Election held in the City of Long Beach, California, on Tuesday, June 7, 2022, for the purpose of nominating and/or electing candidates for the following City Offices: Mayor, City Attorney, City Auditor, City Prosecutor, and five (5) offices on the City Council from District Numbers 1, 3, 5, 7 and 9; and nominating and/or electing candidates for two (2) Long Beach Unified School District Board of Education Offices, District Members 1 and 5; and directing the City Clerk to place on ballots to be used at the General Municipal Election to be held on the 8th day of November 2022, the names of the candidates declared to have been nominated in the Primary Nominating Election; and directing the City Clerk to issue a certificate of Election to the candidate declared to have been elected at the Primary Nominating Election;
2. A Resolution ordering, proclaiming, calling, giving notice of and providing for the holding of a General Municipal Election to be held in the City of Long Beach, California, on Tuesday, the 8th day of November, 2022, for the purpose of nominating and/or electing candidates for the Mayor, three (3) offices on the City Council from District Numbers 3, 5 and 9, and for one (1) Long Beach Unified School District Governing Board Member from District 1, for a full term of four (4) years commencing with the third Tuesday of December, 2022; and adopting provisions relating to translations of and the charges for costs of candidate statements.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DECLARING THE RESULTS OF THE PRIMARY NOMINATING ELECTION HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY, JUNE 7, 2022 FOR THE PURPOSE OF NOMINATING AND/OR ELECTING CANDIDATES FOR THE FOLLOWING CITY OFFICES: MAYOR, CITY ATTORNEY, CITY AUDITOR, CITY PROSECUTOR, AND FIVE (5) OFFICES ON THE CITY COUNCIL FROM COUNCIL DISTRICT NUMBERS 1, 3, 5, 7 AND 9; NOMINATING AND/OR ELECTING CANDIDATES FOR TWO (2) LONG BEACH UNIFIED SCHOOL DISTRICT BOARD OF EDUCATION OFFICES, DISTRICT NUMBERS 1 AND 5; AND DIRECTING THE CITY CLERK TO PLACE ON THE BALLOTS TO BE USED AT THE GENERAL MUNICIPAL ELECTION TO BE HELD ON NOVEMBER 8, 2022, THE NAMES OF THE CANDIDATES DECLARED TO HAVE BEEN NOMINATED IN THE PRIMARY NOMINATING ELECTION; AND DIRECTING THE CITY CLERK TO ISSUE A CERTIFICATE OF ELECTION TO THE CANDIDATES DECLARED TO HAVE BEEN ELECTED AT THE PRIMARY NOMINATING ELECTION

WHEREAS, the City Council of the City of Long Beach did, by Resolution No. RES-22-0017, duly call and provide for the holding of a Primary Nominating Election on Tuesday, June 7, 2022, for the purpose of nominating and/or electing candidates for the

1 following City Offices: Mayor, City Attorney, City Auditor, City Prosecutor and five (5) City
2 Council Offices, namely for the First, Third, Fifth, Seventh and Ninth Districts; and, two (2)
3 Long Beach Unified School District Governing Board Members, District 1 and 5; and

4 WHEREAS, the election was held in the City of Long Beach on that day; and

5 WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk, duly
6 canvassed the returns of the election and has transmitted the results to the City Clerk;

7 NOW, THEREFORE, the City Council of the City of Long Beach does
8 resolve, determine, order and declare as follows:

9 Section 1. That the Primary Nominating Election for the purpose of
10 nominating and/or electing candidates as required by law for the following City Offices:

14 in connection with the election which were returned at the time and in the form and manner
15 required by law were all duly and regularly canvassed. That the Los Angeles County
16 Registrar-Recorder/County Clerk has duly canvassed the returns of the election and filed
17 the Certificate of Canvass with the City Council and from that certification the City Council

5 governing the nomination and/or election of candidates for this office, Doug Haubert is
6 declared elected to the office of City Prosecutor for the full term of four (4) years
7 commencing with the third Tuesday of December, 2022. The City Clerk is directed to issue
8 to Doug Haubert a Certificate of Election certifying to the election to this office for such
9 term.

10 Section 20. That Mary L. Zendejas received a majority of the votes cast of
11 all candidates for the office of Member of the City Council, First District, and in accordance
12 with the provision of law governing the nomination and/or election of candidates for this
13 office, Mary L. Zendejas is declared elected to the office of Member of the City Council,
14 First District for the full term of four (4) years commencing with the third Tuesday of
15 December, 2022. The City Clerk is directed to issue to Mary L. Zendejas a Certificate of
16 Election certifying to the election to this office for such term.

17 Section 21. That Roberto Uranga received a majority of the votes cast of all

19 WHEREAS, the City Council of the City of Long Beach did, by Resolution No.
20 RES-22-0017, duly call and provide for the holding of a Primary Nominating Election on
21 Tuesday, June 7, 2022; and

22 WHEREAS, the Primary Nominating Election was held in the City of Long
23 Beach on Tuesday, June 7, 2022, and certain candidates have been nominated for the

Section 7. Notice is given of the holding and of the time and place of the election.

Section 8. The polls for the General Municipal Election shall be open at 7:00 a.m. and shall be kept open until 8:00 p.m. when the polls shall be closed; except that, if at the hour of closing there are any voters in the vote center or in line at the door who are qualified to vote, and who have not been able to do so since appearing, the polls shall be kept open a sufficient time to enable them to vote; but no one who arrives at the polling place after 8:00 p.m. shall be entitled to vote, although the polls may be open when such person arrives.

1 Section 9. California Elections Code Section 13307 requires that a
2 candidate's statement must be translated in Spanish at the candidate's request. Further,
3 in accordance with the requirements of the federal Voting Rights Act of 1965 (PL 94-73) all
4 candidates' statements shall be translated into the languages indicated for Mayor, Member
5 of the City Council for the Third, Fifth and Ninth Council Districts as follows: Khmer,
6 Korean, Spanish, Tagalog, and Vietnamese. A candidate shall not be required to pay for
7 the cost of translating his or her candidate's statement into any foreign language required
8 pursuant to federal and/or state law. However, a candidate shall be required to pay the
9 cost of printing the candidate's statement in the sample ballot pamphlet in the English
10 and/or Spanish language.

11 Section 10. Pursuant to Section 13307 of the California Elections Code, a
12 charge shall be levied against each candidate for the costs of the candidate's statements
13 sent to each voter. The City Clerk is directed and authorized to establish and implement
14 the charge for the costs of printing, handling, translating, and mailing any candidate
15 statements as provided in Elections Code Section 13307. Any allegation of indigency or
16 inability to pay the requisite fee in advance shall be handled by the City Clerk in accordance
17 with the provisions of Elections Code Section 13309.

18 Section 11. The City Clerk shall provide each candidate or the candidate's
19 representative with a copy of the resolution.

20 Section 12. This resolution shall take effect immediately upon its adoption
21 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
