3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO ACCEPT A GRANT FROM THE  
6 CALIFORNIA DEPARTMENT OF JUSTICE SPOUSAL  
7 ABUSER PROSECUTION PROGRAM (SAPP) AND  
8 AUTHORIZING THE CITY MANAGER TO EXECUTE ALL  
9 NECESSARY CONTRACTS AND CONTRACTS ON  
10 BEHALF OF THE CITY.

12 WHEREAS, the Long Beach City Prosecution has implemented a specialized  
13 unit for the prosecution of domestic violence crimes, and;

14 WHEREAS, the California Department of Justice offers grants of State  
15 supplemental funds in the approximate sum of Forty Three Thousand Five Hundred  
16 Fifty-Seven Dollars (\$43,557.00) for such prosecution programs through the Spousal  
17 Abuser Prosecution Program known as "SAPP", and;

18 WHEREAS, the Long Beach City Prosecutor desires such supplemental funds  
19 in order to enhance the successful prosecution of spousal abuse, elder abuse, and  
20 child abuse crimes in the City of Long Beach, and;

21 WHEREAS, the State grant for SAPP funds requires the City of Long Beach to  
22 commit city funds in an amount not to exceed Eight Thousand Seven Hundred Eleven  
23 Dollars and forty cents (\$8,711.40);

24 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
25 follows:

26 Section 1. The City's participation in the SAPP program is hereby approved.  
27 The City Manager is hereby authorized to take such steps as may be necessary to  
28 submit a SAPP grant application to the California Department of Justice, to execute all

1 grant application documents and or agreements, to accept on behalf of the City of  
2 Long Beach a SAPP grant in the approximate amount of Forty Three Thousand Five  
3 Hundred Fifty-Seven Dollars (\$43,557.00), and make an expenditure of City funds in  
4 an amount not to exceed Eight Thousand Seven Hundred Eleven Dollars and forty  
5 cents (\$8,711.40) to match the SAPP grant funds received. No portion of the SAPP  
6 grant funds shall be used to supplant local expenditures.

7 Section 2. It is agreed that any liability arising out of the performance of the  
8 above-mentioned grant award agreement, including civil court actions for damages,  
9 shall be the responsibility of the grant recipient and the authorizing agency. The State  
10 of California and the Department of Justice disclaim responsibility for any such liability.

11 Section 3. This resolution shall take effect immediately upon its adoption by  
12 the City Council, and the City Clerk shall certify the vote adopting this resolution.
