A RESOLUTION OF THE CITY COUNCIL OF THE

DEVELOPMENT, INC., WITHOUT ADDITIONAL

ADVERTISING FOR BIDS, FOR THE RE-ROOF AT

STEARNS PARK COMMUNITY CENTER, IN AN AMOUNT

NOT TO EXCEED \$762,810, PLUS A 15 PERCENT

CONTINGENCY IN THE AMOUNT OF \$114,422, FOR A

TOTAL CONTRACT AMOUNT NOT TO EXCEED \$877,232

WHEREAS, on August 9, 2018, the City of Long Beach (the "City") scheduled a bid opening for sealed competitive bids for the Re-Roof at Stearns Park Community Center, located at 4520 E. 23<sup>rd</sup> Street, Long Beach, CA 90815 (the "Project");

WHEREAS, on August 9, 2018, only one (1) bid was received for the Project; and

WHEREAS, Exbon Development, Inc. ("Exbon") submitted the sole bid for the Project, however it was deemed non-responsive because it failed to meet one of the administrative requirements related to subcontractor outreach as outlined in the bid documents for the Project; and

WHEREAS, as a result, no bids were received that met the bidding requirements as outlined in the bid documents for the Project; and

WHEREAS, Public Contract Code Section 20166 permits the City to dispense with competitive bidding if no bids are received, and it states, "if no bids are received, the legislative body may have the project done without further complying with this chapter" (i.e., the City may directly engage contractors without further competitive

bidding);
NOW, THEREFORE, the City Council of the City of Long Beach resolves as
follows:
Section 1. The City Council finds that after fully complying with the Public
Contract Code, no responsive bids were received for the Re-Roof at Stearns Park
Community Center Project.
Section 2. Pursuant to Public Contract Code Section 20166, the City
Manager, or designee, is hereby authorized to enter a contract with Exbon Development,
Inc., including any necessary amendments thereto, for the Re-Roof at Stearns Park
Community Center, located at 4520 E. 23 <sup>rd</sup> Street, Long Beach, CA 90815, in an amount
not to exceed Seven Hundred Sixty-Two Thousand Eight Hundred Ten Dollars
(\$762,810), plus a fifteen percent (15%) contingency in the amount of One Hundred
Fourteen Thousand Four Hundred Twenty-Two Dollars (\$114,422), for a total contract
amount not to exceed Eight Hundred Seventy-Seven Thousand Two Hundred Thirty-Two
Dollars (\$877,232), without additional advertising for bids.
Section 3. This resolution shall take effect immediately upon its adoption

ion by the City Council, and the City Clerk shall certify the vote adopting this resolution.
