The City of Long Beach and the Health and Human Services Department continues to stand for racial equity and a discrimination-free workplace across the City and will continue to work to build community trust by listening, learning and fostering an environment of partnership.

Good afternoon!

I hope that you had/having a wonderful summer. You are receiving this email as you attended one of the Community Crisis Response community sessions earlier this year. The last time we had the opportunity to meet, our team shared that the Health Department would be contracting with a local organization to run the Community Crisis Response Pilot and that Request for Proposals (RFP) would be released in the summer. Last month, the Health Department was informed that the team will now housed within the Health Department rather than be contracted out as a result of internal policies related to contracts and personnel. Thought this pivot results in a delay (launch in January 2023), the Health Department will now have more control of the pilots implementation and on-going investment.

Related to that, as of last night, four of the five Community Crisis Response job postings are now open!!! The last position, the Public Health Nurse, will post in a few weeks, as it will only be open only for a week based on its filling requirements. On average job bulletins such as this can take up to 8 weeks for approvals and posting, whereas these took less than four! This is a direct result of City leadership being very excited and eager for this team to launch.
