1 FIRST AMENDMENT TO AGREEMENT NO. 33736

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33736 is made and
4 entered, in duplicate, as of December 14, 2015, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 December 16, 2014, by and between THE BOLDER GROUP, INC., a California
7 corporation ("Consultant"), with a place of business at 227 Marina Drive, Long Beach,
8 California, 90803, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City's need to purchase marine fuel and related supplies
10 could only be met by Contractor; and

11 WHEREAS, the parties entered Agreement No. 33736 whereby Consultant
12 agreed to provide these services; and

13 WHEREAS, the parties desire to extend the term and add the annual
14 amount of \$82,500 for a total not to exceed contract amount of \$247,500;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 2. Of Agreement No. 33736 is hereby amended to read as
18 follows:

19 "2. City shall pay Contractor in due course of payments for the
20 marine fuel and related supplies a total amount of \$247,500, for the term of the entire
21 contract including tax."

22 2. Section 3. Of Agreement No. 33736 is hereby amended to read as
23 follows:

24 "3. The term of this Contract shall commence at midnight on
25 January 1, 2015, and shall terminate on June 30, 2016."

26 3. Except as expressly modified herein, all of the terms and conditions
27 contained in Agreement No. 33736 are ratified and confirmed and shall remain in full
28 force and effect.
