3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE AN AGREEMENT AND ANY
6 AMENDMENTS THERETO WITH PLAYCORE WISCONSIN,
7 INC., DBA GAMETIME, FOR THE PURCHASE AND
8 INSTALLATION OF PLAYGROUND AND OUTDOOR
9 FITNESS EQUIPMENT, SITE ACCESSORIES,
10 SURFACING, AND RELATED PRODUCTS AND SERVICES
11 ON AN AS-NEEDED BASIS, ON THE SAME TERMS AND
12 CONDITIONS AFFORDED TO THE CITY OF CHARLOTTE,
13 NC, THROUGH OMNIA PARTNERS, IN AN ANNUAL
14 AMOUNT NOT TO EXCEED \$3,300,000

16 WHEREAS, the Charter of the City of Long Beach (the "City"), Section
17 1802, permits the City to purchase services, supplies, materials, equipment and labor
18 with other government agencies by purchasing under their contracts on a voluntary and
19 selective basis when authorized by resolution; and

20 WHEREAS, the City desires the purchase and installation of playground
21 and outdoor fitness equipment, site accessories, surfacing, and related products and
22 services on an as-needed basis for use in City park development and improvement
23 projects; and

24 WHEREAS, the City of Charlotte, NC, has a Contract through OMNIA
25 Partners with Playcore Wisconsin, Inc., dba GameTime, for the purchase and installation
26 of playground and outdoor fitness equipment, site accessories, surfacing, and related
27 products and services, Contract No. 2017001134 ("Charlotte Contract"); and

28 WHEREAS, the City's participation in the Charlotte Contract will facilitate

1 the City's ability to purchase and install playground and outdoor fitness equipment, site
2 accessories, surfacing, and related products and services on an as-needed basis as well
3 as provide considerable cost benefits to the City; and

4 WHEREAS, if the City had to utilize a formal bid process rather than
5 participate in the Charlotte Contract considerably more funds would be required;

6 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
7 follows:

8 Section 1. The above recitals are true and correct and are incorporated
9 herein by this reference.

10 Section 2. The City Manager or designee is hereby authorized to enter
11 an agreement and any amendments thereto with Playcore Wisconsin, Inc., dba
12 GameTime for the purchase and installation of playground and outdoor fitness
13 equipment, site accessories, surfacing, and related products and services on an as-
14 needed basis, of the same type and kind identified in the Charlotte Contract except as
15 modified by mutual agreement of the City and Playcore Wisconsin, Inc., dba GameTime,
16 and the purchase by the City shall be on the same terms and conditions afforded to the
17 City of Charlotte, NC, through OMNIA Partners, in an annual amount of Three Million
18 Dollars (\$3,000,000), with a ten percent (10%) contingency of Three Hundred Thousand
19 Dollars (\$300,000), for a total annual contract amount not to exceed Three Million Three
20 Hundred Thousand Dollars (\$3,300,000), until the Charlotte Contract expires on June 30,
21 2022, with the option to renew for as long as the Charlotte Contract is in effect, at the
22 discretion of the City Manager.

23 Section 3. This resolution shall take effect immediately upon its adoption
24 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
