3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH ESTABLISHING AN ANNUAL
5 SPECIAL TAX FOR COMMUNITY FACILITIES DISTRICT
6 NO. 2007-2 (BELMONT SHORE) FOR FISCAL YEAR 2021-
7 2022

9 WHEREAS, the City Council of the City of Long Beach (hereinafter referred
10 to as the "legislative body") initiated proceedings, held a public hearing, conducted an
11 election and received a favorable vote from the qualified electors relating to the levy of a
12 special tax in a community facilities district, all as authorized pursuant to the terms and
13 provisions of the "Mello-Roos Community Facilities Act of 1982", being Chapter 2.5, Part 1
14 of Division 2, Title 5 of the Government Code of the State of California. This Community
15 Facilities District shall hereinafter be referred to as Community Facilities District No. 2007-
16 2 (Belmont Shore); and

17 WHEREAS, this legislative body, by ordinance as authorized by Section
18 53340 of the government code of the State of California, has authorized the levy of a
19 special tax to pay for costs and expenses related to said Community Facilities District, and
20 this legislative body is desirous to establish the specific rate of the special tax to be
21 collected for the next fiscal year; and

22 WHEREAS, the levy had been set at a rate of \$0.12 per commercial lot
23 square-foot for Fiscal Years 2006 through 2018; and

24 WHEREAS, the levy had been set at a rate of \$0.15 per commercial lot
25 square-foot for Fiscal Year 2019; and

26 WHEREAS, the levy had been set at a rate of \$0.14 per commercial lot
27 square-foot for Fiscal Years 2020 through 2021; and

28 WHEREAS, projections to cover operating costs and consultant and trustee

1 fees show a continued rate of \$0.14 per commercial lot square-foot and is being
2 recommended for Fiscal Year 2022;

3 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
4 follows:

5 Section 1. The above recitals are all true and correct.

6 Section 2. That the specific rate and amount of the special tax to be
7 collected to pay for the costs and expenses for the next fiscal year (2021-2022) for
8 Communities Facilities District 2007-2 (the "District") is hereby determined and
9 established as set forth in Exhibit "A", attached hereto and incorporated herein.

10 Section 3. That the rate as set forth above does not exceed the amount
11 as previously authorized by ordinance of this legislative body, and is not in excess of that
12 as previously approved by the qualified electors of the District.

13 Section 4. The proceeds of the special tax shall be used to pay, in whole
14 or in part, the costs of the following, in the following order of priority:

15 A. Payment of principal of and interest on any outstanding
16 authorized bonded indebtedness;

17 B. Necessary replenishment of bond reserve funds or other
18 reserve funds;

19 C. Payment of costs and expenses of authorized public facilities;

20 D. Repayment of advance and loans, if appropriate.

21 The proceeds of the special taxes shall be used as set forth above, and
22 shall not be used for any other purpose.

23 Section 5. The special tax shall be collected in the same manner as
24 ordinary ad valorem property taxes are collected, and shall be subject to the same
25 penalties and same procedure and sale in cases of any delinquency for ad valorem
26 taxes, and the Tax Collector is hereby authorized to deduct reasonable administrative
27 costs incurred in collecting any said special tax.

28 Section 6. All monies above collected shall be paid into the Community

1 Facilities District funds, including any bond fund and reserve fund.

2 Section 7. The Auditor of the County is hereby directed to enter in the
3 next County assessment roll on which taxes will become due, opposite each lot or parcel
4 of land affected in a space marked "public improvements, special tax" or by any other
5 suitable designation, the installment of the special tax, and for the exact rate and amount
6 of said tax, reference is made to the attached Exhibit "A".

7 Section 8. The County Auditor shall then, at the close of the tax
8 collection period, promptly render to this Agency a detailed report showing the amount
9 and/or amounts of such special tax installments, interest, penalties and percentages so
10 collected and from what property collected, and also provide a statement of any
11 percentages retained for the expense of making any such collection.

12 Section 9. This resolution shall take effect immediately upon its adoption
13 by the City Council, and the City Clerk shall certify the vote adopting this resolution.


