**STATEMENT IN SUPPORT OF THE PROPOSED SENIOR FACILITY AND THE
RECOMMENDED ENABLING LEGISLATION; AND IN REBUTTAL TO PRINCIPAL POINTS
MADE BY APPELLANTS AND PROTESTERS**

I am Joe Weinstein, property owner and resident, 4000 Linden Ave., in Bixby Knolls. I live 3 blocks north and one block east of the Project site at the southwest corner of Elm and 37-th.

I have worked to defend and enhance quality of life and property values in our neighborhood and elsewhere in the city. Pursuant to this aim, in recent years I have come before the City Council to appeal poorly conceived decisions of the Planning Commission made in favor of big high-impact projects despite grossly inadequate impact analyses (EIRs). These projects included the NLB Police Station in Scherer Park, the so-called Sports Park in the Willow-Spring Natural Area, and the attempt to expand Long Beach Airport operations under cover of cosmetic improvements. I will not hesitate to oppose future misconceived projects. I applaud LB Neighborhoods First for helping appellants to present a case today.

BUT all these facts do NOT mean that in this case appellants' points outweigh the benefits of this Project, or even that these points fairly and relevantly describe the salient facts.

In fact, these points – both in fliers received on my doorstep and in the long appeal texts - are largely alarmist bugaboos, marginally true in theory but of little or no practical import and impact.

THE MISLEADING APPEAL AND FLIER RHETORIC tacitly exploits a faulty picture of the so-called Chateau Thierry neighborhood as if it were everywhere primarily single-family residential. This area – which consists mainly of properties along Elm and Linden Avenues – lies between LB Blvd on the west and Atlantic on the east, from Wardlow Rd on the south to San Antonio on the north.

IN REALITY, the area divides into two quite different parts, a NORTHERN and a SOUTHERN, meeting at 37-th street. Calling these parts by a common name does not change this reality.

In the SOUTH, the terrain is fairly FLAT, there are FEW STREET TREES or other greenery, and DEVELOPMENT IS A MIX OF HIGH-RISE MULTIFAMILY RESIDENCES AND OF INSTITUTIONS - 3 and 4-story apartments and condos, and churches and synagogue and Petroleum Club. From the Project site one need go less than 1 block south on Elm, and less than 1 block east on 37-th, to encounter 3 and 4-story apartment and condo buildings.

The NORTH, however, is NOT FLAT – IT RISES NOTABLY AS YOU GO NORTH FROM 37-th, in particular as you walk north from the Project site. Everywhere there are MANY MATURE STREET TREES and yard shrubs. Although the two corner parcels on Elm N. of 37-th are institutional – the LDS (Mormon) Church and the Boy Scout Bldg – then and thereafter SINGLE FAMILY single-family residences take over (except much farther north, on a couple blocks north of Carson).
