- 1. Term: The term of this Agreement shall commence on December 15, 2009 and terminate on January 31, 2011.
- Amount: The maximum amount of grant funding for this project is

- D. Grantor will be responsible for any additional costs for the project due to change orders, cost overruns or scope of work changes only with prior written approval by its Board of Directors;
