FIRST AMENDMENT TO AGREEMENT NO. 31328

31328

THIS FIRST AMENDMENT TO AGREEMENT NO. 31328 is made and entered, in duplicate, as of January 9, 2012, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on July 7, 2009, by and between the CITY OF LONG BEACH, a municipal corporation ("City") and SBC GLOBAL SERVICES, INC., a Delaware Corporation, doing business as AT&T GLOBAL SERVICES, Inc. dba AT&T Global Services (AT&T) whose address is 1150 S. Olive Street, Room 1820, Los Angeles, California 90015 ("Contractor").

WHEREAS, City desires to continue procuring long distance calling, Internet and other telecommunication services; and

WHEREAS, Contractor entered into State of California Agreement Numbers DTS 06E1390 and DTS 06E1391 ("CALNET 2") pursuant to which Contractor delivers telecommunication services to the State of California and other political subdivisions who participate in "CALNET 2";

NOW, THEREFORE, in consideration of the mutual covenants herein contained, City and Contractor agree as follows:

1. Section 1.B. of Agreement No. 31328 is deleted in its entirety and amended to read as follows:

"B. The extended term of this Agreement shall commence on January 29, 2012, and terminate on January 29, 2013. City's City Manager shall have the option of renewing this agreement for one (1) additional year. City shall have the right to terminate this Agreement at any time by giving thirty (30) days written notice to Contractor. The terms and conditions contained in Section 4 of both ATOs shall control in the event of such early termination by City."

2. Section 1.D. of Agreement No. 31328 is deleted in its entirety and amended to read as follows:

"D. Wherever "CALNET 2" refers to the contract sum, it shall be deemed

1 to mean an amount not to exceed One Hundred Eighteen Thousand Dollars
2 (\$118,000.00) per year."

3 3. Except as set forth in This First Amendment, all terms and conditions
4 of Agreement No. 31328 are ratified and confirmed and shall remain in full force and
5 effect.

8 opposite their signatures.

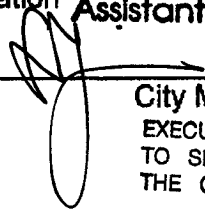

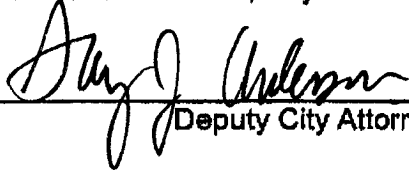
