

FOURTH AMENDMENT TO AGREEMENT NO. 28247

THIS FOURTH AMENDMENT TO AGREEMENT NO. 28247 is made and entered, in duplicate, as of July 23, 2007 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 17, 2007, by and between BUREAU VERITAS NORTH AMERICA, INC. (formerly known as BERRYMAN & HENIGAR), a Delaware corporation ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 28247 whereby Consultant agreed to provide specialized services requiring unique skills to be performed in connection with As-Needed Architectural & Engineering Design ("Project"); and

WHEREAS, the First Amendment to Agreement No. 28247 increased the contract amount by \$600,000, for an amount not to exceed \$1,200,000; and

WHEREAS, the parties desire to again increase the total Agreement amount;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this Amendment, the parties agree as follows:

1. Section 1.A. of Agreement No. 28247 is amended in its entirety to read as follows:

"1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly set forth in Exhibit "A", attached to the Agreement and incorporated herein by this reference, in accordance with the standards of the profession, and City shall pay for said services in the manner described below, and City desires to increase the Contract amount by \$500,000, for a total amount, not to exceed \$1,700,000.00."


