

1 FIRST AMENDMENT TO CONTRACT NO. 31718

3 THIS FIRST AMENDMENT TO CONTRACT NO. 31718 is made and  
4 entered, in duplicate, as of April 5, 2011 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 September 22, 2009, by and between ARINC INCORPORATED, a Delaware corporation  
7 ("Contractor"), with a place of business at 1840 Hutton Drive, Suite 160, Carrollton,  
8 Texas 75006, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City and Contractor entered into Contract No. 31718  
10 whereby Contractor agreed to provide specialized services requiring unique skills to be  
11 performed in connection with design, project management and installation of additional  
12 security equipment required by the U.S. Department of Homeland Security,  
13 Transportation Security Administration at the Long Beach Airport; and

14 WHEREAS, the parties desire to extend the term of the Contract;

15 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
16 the Contract and in this First Amendment, the parties agree as follows:

17 1. Section 5 of Contract No. 31718 is hereby amended to read as  
18 follows:

19 "5. TIME FOR CONTRACT. The term of this Contract shall commence  
20 at midnight on January 15, 2010, and shall terminate at 11:59 p.m. on April 30, 2012,  
21 unless sooner terminated as provided in this Contract, or unless the services or the  
22 Project is completed sooner."

23 2. Except as expressly amended in this First Amendment, all terms and  
24 conditions in Contract No. 31718 are ratified and confirmed and shall remain in full force  
25 and effect.


