**Subject:** **Transfer of Funds: Tichenor Clinic for Children- 7<sup>th</sup> Annual Superheroes Carnival & Resource Fair**

**RECOMMENDATION:**

Increase appropriations in the General Fund Group in the City Manager Department by \$1,000, offset by the \$500 of the Fourth Council District One-time District Priority Funds and \$500 of the Third Council District One-time District Priority Funds transferred from the Citywide Activities Department to provide a contribution to the Tichenor Clinic for Children for the 7<sup>th</sup> Annual Superheroes Carnival & Resource Fair; and,

Decrease appropriations in the General Fund Group in the Citywide Activities Department by \$1,000 to offset a transfer to the City Manager Department.

**DISCUSSION:**

The Tichenor Clinic is hosting 7<sup>th</sup> Annual Superheroes Carnival & Resource Fair on June 4, 2022. Supplemental funding was needed for this community event.

This matter has been reviewed by Budget Manager Grace H. Yoon on May 19, 2022.

**FISCAL IMPACT:**

This recommendation requests the City Manager to provide a contribution to the Tichenor Clinic for Children for the 7<sup>th</sup> Annual Superheroes Carnival & Resource Fair. The total appropriation increase of \$1,000 in the General Fund Group in the City Manager Department will be offset by a decrease of appropriation from the Fourth Council District One-time District Priority Funds and the Third Council District One-time District Priority Funds in the General Fund Group in the Citywide Activities Department. The recommendation is anticipated to require a minimal level of staff hours beyond the normal budgeted scope of duties and is expected to have a minimal impact on existing City Council priorities.

Action is needed tonight to ensure that this organization has access to the sponsorship to be able to plan and execute a successful event on Saturday, June 4, 2022.
