FIRST AMENDMENT TO AGREEMENT NO. 32576

THIS FIRST AMENDMENT TO AGREEMENT NO. 32576 is made and entered, in duplicate, as of December 20, 2013, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on December 20, 2011, by and between TERRY A. HAYES ASSOCIATES INC., a California corporation ("Consultant"), with a place of business at 8522 National Boulevard, Suite 102, Culver City, California 90232, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with on-call environmental consultant services ("Project"); and

WHEREAS, the parties entered Agreement No. 32576 whereby Consultant agreed to provide these Services; and

WHEREAS, the parties desire to extend the term and increase the total Agreement amount;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 1.A. of Agreement No. 32576 is hereby amended to read as follows:

"1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000), at the rates or charges shown in Exhibit "B".

2. Section 2 of Agreement No. 32576 is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on


1 January 1, 2012, and shall terminate at 11:59 p.m. on December 31, 2014, unless sooner
2 terminated as provided in this Agreement, or unless the services or the Project is
3 completed sooner.”

4 3. Except as expressly modified herein, all of the terms and conditions
5 contained in Agreement No. 32576 are ratified and confirmed and shall remain in full
6 force and effect.


