Main Street, Suite 400, Santa Ana, California 92705, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35531 (the "Agreement") whereby Consultant agreed to provide construction management services for the Phase II Terminal Area improvements at the Long Beach Airport; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to update the fee schedule; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$3,538,000 for a total not to exceed amount of \$7,485,343 and attach an updated fee schedule; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to update the fee schedule; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to update the fee schedule; and

WHEREAS, the Parties desire to add \$3,900,000 to the Agreement for a total not to exceed amount of \$11,385,343, and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A of the Agreement is hereby amended to read as follows:

- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on May 13, 2020, and shall terminate at 11:59 p.m. on May 12, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for one (1) additional one-year period at the discretion of the City Manager."
