Comment/Correction: Remove Anna Christensen/Phil Geison/Long Beach Area Peace Network from The Community Working Group list.

The Community Working group did not include Anna Christensen, Phil Geison, or any other members of the Long Beach Area Peace Network. Phil and I attended a single community meeting where we proposed that the City not build Belmont Beach and Aquatics Center/BBAC as it was environmentally unjust and would become inaccessible and unsafe due to sea level rise and storm surges during its lifetime.

Meeting attendees were informed by Chris Kootz of Development Services that a phase out oil and gas operations would not be addressed in the CAAP. It appeared that we were being recruited to sell an already formulated CAAP in disadvantaged areas by explaining it to residents in a simplified manner following a script. We did not feel heard.
