SECOND AMENDMENT TO CONTRACT NO. 32934
32934

THIS SECOND AMENDMENT TO CONTRACT NO. 32934 is made and entered, in duplicate, as of December 3, 2013 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on May 14, 2013, by and between ALLSTATE ENGINEERING, a California corporation ("Contractor"), whose address is 1206 S. Alvarado Street, Unit A, Los Angeles, California 90006, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, pursuant to a "Notice Inviting Bids for Job Order Contract (JOC) in the City of Long Beach, California," dated February 2012, and published by City, bids were received, publicly opened and declared on the date specified in said Notice; and

WHEREAS, the parties entered into Contract No. 32934 for the work described in the bid documents; and

WHEREAS, the parties desire to increase the Contract amount by \$1,500,000 for tenant and security improvements at the Interim Port Headquarters Building; and

NOW, THEREFORE, in consideration of the terms and conditions contained herein, the parties agree as follows:

1. Section 2.A. of Contract No. 32934 is hereby amended to read as follows:

"2. PRICE AND PAYMENT.

A. City shall pay to Contractor the amount(s) for each Work Order based on the adjustment factor in Contractor's Bid, attached hereto as Exhibit "A"; provided, however, that City shall not pay more than Four Million Five Hundred Thousand Dollars (\$4,500,000) for the term of the Contract, of which \$1,500,000 is for use by the Port of Long Beach for tenant and security improvements at its Interim Port Headquarters Building."
