RESOLUTION NO. RES-06-0107

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH ESTABLISHING A PARTIAL SCHEDULE OF FEES AND CHARGES FOR SPECIFIED CITY SERVICES FOR THE DEPARTMENTS OF COMMUNITY DEVELOPMENT, FINANCIAL MANAGEMENT, FIRE, HEALTH AND HUMAN SERVICES, PARKS, RECREATION AND MARINE, PLANNING AND BUILDING, POLICE, AND PUBLIC WORKS

WHEREAS, the City Council of the City of Long Beach ("City") seeks to establish service fees and charges to recover the full, lawfully recoverable costs incurred by the City in providing services to those who request them; and

WHEREAS, it is the City's policy to set service fees and charges at full cost recovery levels, except where a greater public benefit is demonstrated to the satisfaction of the City Council, or when it is not cost effective to do so; and

WHEREAS, the City has conducted an extensive analysis of its services, the costs reasonably borne by the City in providing those services, the beneficiaries of those services, and the revenues produced by those paying service fees and charges for said services; and

WHEREAS, on June 3, 2005, the City retained an independent consultant, Public Resources Management ("PRM"), to conduct an analysis of the City's services and related costs. PRM completed a two phase user fee analysis which was considered by the City Council's Budget Oversight Committee in public meetings conducted on January 26, 2005, August 8, 2005 and February 21, 2006 (the "Fee Studies"), copies of which are on file with the City Clerk. The Fee Studies set forth a mechanism for ensuring that fees adopted by the City for services rendered do not

exceed the reasonable estimated cost for providing the services for which the fees are charged; and

WHEREAS, on September 12, 2006, the City Council, at a duly noticed public hearing, took public testimony and input regarding said proposed service fees and charges described in the PRM Fee Studies; and

WHEREAS, California Government code Section 66000, et. seq. authorizes the City to adopt service fees and charges for municipal services, provided such fees do not exceed the cost to the City of providing the service; and

WHEREAS, in accordance Government Code Section 66016, at least 14 days prior to the public hearing at which this Resolution was adopted, notice of the time and place of the hearing was mailed to eligible interested parties who filed written requests with the City for mailed notice of meetings regarding new or increased fees or service charges; and

WHEREAS, in accordance with the Government Code 66016, data regarding the estimated cost of the services and the revenue sources anticipated to provide the services was available for public review and comment for 10 days prior to the public hearing at which this Resolution was adopted; and

WHEREAS, publication of notice was given in accordance with the provisions of Government Code Section 6062a, ten (10) days in advance of the public hearing at which the adoption of this Resolution was considered; and

NOW, THEREFORE, the City Council of the City of Long Beach does hereby resolve as follows:

Section 1. The facts set forth in the Recitals of this Resolution are true and correct and are hereby incorporated by reference herein as though set forth in full.

Sec. 2. Adoption of the service fees and charges set forth and described in this Resolution are intended to recover costs necessary to provide the services within the City for which the fees are charged. In adopting the service fees and charges set forth in this Resolution, the City Council of the City of Long Beach is exercising its

powers under Article XI, Section 7 of the California Constitution.

Sec. 3. All requirements of California Government Code Sections 66000, et seq., are hereby found to have been satisfied.

Sec. 4. The service fees and charges set forth in Exhibit "A" to this Resolution are reasonable estimates of the costs incurred by the City in providing the services to those who request them. The service fees and charges for such services are necessary to recover the reasonable, estimated cost of providing such services.

Sec. 5. The City Council hereby approves and adopts the Fee Schedule for the Departments of Community Development, Financial Management, Fire, Health and Human Services, Parks, Recreation and Marine, Planning and Building, Police, and Public Works as said fees are set forth in Exhibit "A", which is attached hereto and incorporated herein by this reference as though set forth herein, word for word.

Sec. 6. The service fees and charges adopted and all portions of this Resolution are severable. Should any of the service fees or charges or any portion of this Resolution be adjudged to be invalid and unenforceable by a body of competent jurisdiction, then the remaining fees and/or Resolution portions shall be and continue to be in full force and effect, except as to those fees and/or Resolution portions that have been adjudged invalid. The City Council of the City of Long Beach hereby declares that it would have adopted each of the service fees or charges and this Resolution and each section, subsection, clause, sentence, phrase and other portion thereof, irrespective of the fact that one or more of the service fees, charges or sections, subsections, clauses, sentences, phrases or other portions of this Resolution may be held invalid or unconstitutional.

Sec. 7. All provisions of prior City Council ordinances and resolutions, including Resolution Nos. RES-05-0060, RES-05-0061, RES-05-0086, RES-05-0087, RES-05-0088, C-28494, RES-05-0062, RES-05-0091, RES-05-0059, RES-05-0093, C-28494, RES-05-0058, C-27415, C-27416, C-27740, C-22484, C-25577, C-25848, RES-05-0094, and RES-05-0095, establishing fees which conflict with the terms hereof are

Sec. 8. The establishment of fees and charges herein is exempt from the requirements of the California Environmental Quality Act (CEQA) pursuant to Public Resources Code Section 21080(b)(8) and the adoption of this Resolution is for the purposes of *inter alia*: (1) meeting operating expenses; (2) purchasing or leasing supplies, equipment or materials; (3) meeting financial reserve needs and requirements; or (4) obtaining funds for capital projects, necessary to maintain service within the various areas of the City.

Sec, 9. This Resolution shall be effective upon its adoption, except as to those new fees or charges adopted or increased that relate to "development projects" as that term is defined in Government Code section 66000, in which case said fee or charge shall become effective on the sixty-first (61st) day after the adoption of this Resolution. Said new or increased service fees or charges that relate to "development projects" are more fully described in Exhibit "B" which is attached hereto and incorporated herein by this reference as though set forth herein, word for word.

Sec. 10. This Resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify to the vote adopting this Resolution.

USER FEES BY PROGRAM DEPARTMENT OF HEALTH AND HUMAN SERVICES

I. All third party billings for medical services will be consistent with provisions contained in the 1969, 1974, or latest Revision of the California Relative Value Studies; and/or California Worker's Compensation Official Medical Fee Schedule, 1982 or latest revision thereof; and/or any other fee reimbursement format authorized by the State of California, Department of Health Services.

NOTE:

- 1. Any categories of service not listed above will be charged at a rate not to exceed actual costs.
- 2. The City Health Officer may waive any fees where he/she determines a threat to the public health exists.
- 3. The Department Director may increase or decrease public health vaccine fees to respond to pricing changes.

II. REHABILITATION SERVICES

- A. Alcohol and Drug Services Fees charged will be based upon a sliding scale/ability to pay as approved by the funding and/or authorizing agency.
- B. Rehabilitation and Support Services Fees charged will not exceed the current market value for similar or like services.
- C. Drinking Driver Fees charged are according to an ability to pay but no more than the current State of California, Department of Alcohol and Drug Abuse maximum allowable fee.

III. CHILD HEALTH DISABILITY PREVENTION PROGRAM

Fees charged to the State are in accordance with the California C.H.D.P. fee schedule. Schedule maintained in CHDP clinic.

IV. <u>VITAL STATISTICS</u>

Fees charged are in accordance with the Vital Statistics fee schedule as established by the Department of Health Services, Office of the State Registrar of Vital Statistics.
