3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO PURCHASE TWO DIESEL/WATER JET  
6 PATROL BOATS FROM MOOSE BOATS, INC. ON THE  
7 SAME TERMS AND CONDITIONS AS THE AGREEMENT  
8 WITH THE UNITED STATES GENERAL SERVICES  
9 ADMINISTRATION (GSA)

11 WHEREAS, the Charter of the City of Long Beach (the "City"), Section  
12 1802, permits the City to purchase services, supplies, materials, equipment and labor  
13 with other government agencies by purchasing under their contracts on a voluntary and  
14 selective basis when authorized by resolution; and

15 WHEREAS, the City desires to purchase two diesel water jet patrol boats  
16 for its Police Department using Port Security grant funds; and

17 WHEREAS, the federal General Services Administration has a contract with  
18 Moose Boats, Inc. of Petaluma, California for diesel water jet patrol boats (GSA Schedule  
19 Contract No. GS-07F-0507M); and

20 WHEREAS, City's participation in the GSA Contract GS-07F-0507M will  
21 facilitate acquisition of these items as well as provide considerable cost benefits to the  
22 City; and

23 WHEREAS, if the City had to go to formal bid rather than participate in the  
24 General Services Administration agreement considerably more funds would be required;

25 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
26 follows:

27 Section 1. The above recitals are true and correct and are incorporated  
28 herein by this reference.

Section 2. The City Manager is hereby authorized to enter an agreement with Moose Boats, Inc. for the purchase of one M1 forty-four foot diesel water jet patrol boat in the amount of \$991,588 and one M2 thirty-five foot diesel water jet patrol boat in the amount of \$565,951, on the same terms and conditions as those under GSA Schedule Contract No. GS-07F-0507M, in a total amount not to exceed \$1,557,539, including taxes and shipping, for a period extending until the warranty on the boats expires.

Section 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify to the vote adopting this resolution.
