Dear City Council members and Mayor,

As I'm hopeful you are aware, there are laws in the Great State of California against discrimination. This includes persons that have medical conditions without limitation (as far as I am aware, anyway) or persons who cannot be present at city hall for any reason but still wish to be heard.

I am aware that many Long Beach residents have asked you to make the City Council meetings via Zoom permanent and I cannot imagine how you could not do so, especially given the ease with which this can be done. As someone who has been in the technology sector for 46 years, I certainly can see how important it is to serve all people with it.

In fact, if you are supportive of an open government that is by the people, of the people, and for the people, then how can you not make available teleconference facilities for public participation available for all meetings by default?

There are many reasons why people may not be comfortable attending (or able to attend) a meeting in person. Persons who could be at significant risk attempting to get to, or being in a meeting at city hall, for whatever reason, should not be prevented from attending. There is absolutely no suitable reason why the voices of the people should not be assisted through technology.

By not providing teleconference facilities for every public meeting, you would be creating a situation where citizens (aka voters, and taxpayers) are (1) unable to exercise their right to speak publicly on significant business of the city and (2) expose themselves to a risk (in the case of communicable diseases) that could hasten their own death should they decide they must be heard, which you hopefully know is a significant and reasonable right.
