THIS THIRD AMENDMENT TO AGREEMENT NO. 33567 is made and entered, in duplicate, as of August 3, 2018, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 9, 2014, by and between MLA GREEN, INC., a California corporation, dba STUDIO-MLA, fdba MIA LEHRER + ASSOCIATES, with a place of business at 251 South Mission Road, Los Angeles, California 90033-3235 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with architectural and engineering services related to the planning and design of the Sorrento Alamitos Bay Shoreline Trail, Sidewalks, and Street Improvements; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33567 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the total not to exceed amount to \$243,617 and extend the term to October 1, 2017; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to October 1, 2018; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:
2. TERM. The term of this Agreement shall commence at midnight on October 1, 2014, and shall terminate at 11:59 p.m. on October 1, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the Project is
