Re: Amendment To Rancho Estates (PD-11)


I am writing to support the amendment prohibiting second story additions in the Ranchos. My reasons are as follows:

- 1. The Rancho neighborhood was master-planned for single story homes. The character of the architecture is defined by single story homes with low-slung roofs and clerestory windows. The two story homes already in the neighborhood have a jarring affect on the continuity of the area. Future second story conditions would only further erode the architectural integrity of this unique neighborhood. It's the largest concentration of Cliff May-designed homes and should be afforded some degree of protection from large, unwieldy second story additions.
- 2. The designer placed an emphasis on open plans with natural light by providing clerestory windows at the gables. The design philosophy is well documented in many books and articles about Cliff May and his ranch house concept. The height required by a second story has a profound affect on solar access for natural daylighting. In addition, there are implications in regard to photo voltaic arrays as alternative energy sources become more prevalent.
- 3. Another design character of the Ranchos is their privacy. Privacy was obviously a major design consideration. Second stories can severely encroach on privacy in these homes. Second stories tend to provide a direct view into the clerestory windows at the gables. These triangular clerestory windows are difficult to screen from second story views and, in fact, were never meant to have window treatments such as blinds or drapes. I've attached a line of site diagram illustrating the problem.

Thanks for considering my support of the amendment to PD-11.
