WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed pump station design, operations, and condition assessment services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33483 (the "Agreement") whereby Consultant agreed to perform these services; and

WHEREAS, the Parties desires to extend the term an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on June 11, 2014, and shall terminate at 11:59 p.m. on June 10, 2018, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The Parties have the option to extend the term one (1) additional one-year period, at the discretion of the City Manager."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33483 are ratified and confirmed and shall remain in full force and effect.
