

1 FIRST AMENDMENT TO AGREEMENT NO. 33483

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33483 is made and
4 entered, in duplicate, as of March 30, 2017 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 June 10, 2014, by and between AKM CONSULTING ENGINEERS, a California
7 corporation, with a place of business at 533 Wald, Irvine, California 92618 ("Consultant"),
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed pump station design, operations, and condition
11 assessment services; and

12 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
13 33483 (the "Agreement") whereby Consultant agreed to perform these services; and

14 WHEREAS, the Parties desires to extend the term an additional one (1)
15 year period;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the parties agree as follows:

18 1. Section 2 of the Agreement is hereby amended to read as follows:

19 "2. TERM. The term of this Agreement shall commence at midnight on
20 June 11, 2014, and shall terminate at 11:59 p.m. on June 10, 2018, unless sooner
21 terminated as provided in this Agreement, or unless the services or the Project is
22 completed sooner. The Parties have the option to extend the term one (1) additional
23 one-year period, at the discretion of the City Manager."

24 2. Except as expressly modified herein, all of the terms and conditions
25 contained in Agreement No. 33483 are ratified and confirmed and shall remain in full
26 force and effect.
