- 3. The Agreement, Paragraph 4.0 Term of Agreement, is deleted in its entirety and replaced to read as follows:

"4.0 TERM OF AGREEMENT

The term of this Agreement shall commence on May 1, 2017 and shall expire on December 31, 2020, unless sooner terminated or extended, in whole or in part, as provided in this Agreement.

4. Except for the changes set forth hereinabove, Agreement shall not be changed in any respect by this Amendment.
