7 2. The Scope of Work in Exhibit “A” to the Contract, Exhibit “A-1” to the
8 First Amendment, and Exhibit “A-2” to the Second Amendment are hereby amended to
9 include additional services more particularly described in Exhibit “A-3”, attached hereto and
10 incorporated by this reference.

11 3. Except as expressly modified herein, all of the terms and conditions
12 contained in Contract No. 35022 are ratified and confirmed and shall remain in full force
13 and effect.
