7 DISTRICT FOR THE FOURTH SUPERVISORIAL DISTRICT
8 EXCESS FUNDING FOR DRAKE/CHAVEZ GREENBELT,
9 PACIFIC ELECTRIC RIGHT-OF-WAY, AND WRIGLEY
10 GREENBELT TRAIL

12 WHEREAS, the people of the County of Los Angeles on November 3, 1992,
13 and on November 5, 1996 enacted Los Angeles County Proposition A, Safe
14 Neighborhood Parks, Gang Prevention, Tree Planting, Senior and Youth Recreation,
15 Beach and Wildlife Protection (the Propositions), which among other uses, provides
16 funds to public agencies and nonprofit organizations in the County for the purpose of
17 acquiring and/or development facilities and open space for public recreation; and

18 WHEREAS, the Propositions also created the Los Angeles County
19 Regional Park and Open Space District (the District) to administer said funds; and

20 WHEREAS, the District has set forth the necessary procedures governing
21 application for grant funds under the Propositions, and

22 WHEREAS, the District's procedures require the City of Long Beach to
23 certify, by resolution, the approval of the application before submission of said
24 application(s) to the District; and

25 WHEREAS, said application contains assurances that the City of Long
26 Beach must comply with; and

27 WHEREAS, the City of Long Beach will enter into an Agreement with the
28 District to provide funds for acquisition and development projects;

Section 2. Certifies that the City of Long Beach understands the
assurances and certification in the application form; and

Section 3. Certifies that the City of Long Beach has, or will have,
sufficient funds to operate and maintain the project in perpetuity; and

Section 4. Appoints the City Manager, or designee, to conduct all
negotiations, and to execute and submit all documents including, but not limited to,
applications, agreements, amendments, payment requests and so forth, which may be
necessary for the completion of the aforementioned project.


Section 5. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
