SECOND AMENDMENT TO AGREEMENT NO. 35064

GROVE ST., ANAHEIM, CA 92806, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35064 ("Agreement") whereby Contractor agreed to provide Winchester ammunition; and

WHEREAS, the Parties entered into a First Amendment to extend the term of the Agreement and attach an updated rate schedule;

WHEREAS, the Parties desire to extend the term of the Agreement for an additional one-year period and attach the updated rate schedule.

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 3. of Agreement No. 35064 is hereby amended to read as follows:
- "3. The City may terminate this Contract by giving thirty (30) days prior notice of termination to Contractor."
- The Rates contained in Exhibit "A-2" to this Amendment hereby replace and supersede the rates attached to the Agreement. Exhibit "A-2" to this Amendment is hereby incorporated into the Agreement as a replacement to Exhibit "A-1".
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35064 are ratified and confirmed and shall remain in full force
