

1 FIRST AMENDMENT TO AGREEMENT NO. 34176

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34176 is made and
4 entered, in duplicate, as of October 11, 2018 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April
6 3, 2018, by and between PSOMAS, a California corporation ("Consultant"), with a place of
7 business at 555 South Flower Street, Los Angeles, California 90071, and the CITY OF
8 LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed professional engineering services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
12 34176 (the "Agreement") whereby Consultant agreed to provide these specialized
13 services; and

14 WHEREAS, the Parties desire to add \$1,000,000 to the Agreement for a total
15 not to exceed amount of \$4,000,000 and extend the term one (1) additional one-year
16 period;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions herein contained, the Parties agree as follows:

19 1. Section 1.A. of the Agreement is hereby amended to read as follows:

20 "A. Consultant shall furnish specialized services more particularly
21 described in Exhibit "A", attached to this Agreement and incorporated by this
22 reference, in accordance with the standards of the profession, and City shall pay for
23 these services in the manner described below, not to exceed Four Million Dollars
24 (\$4,000,000), at the rates or charges shown in Exhibit "B"."

25 2. Section 2 of the Agreement is hereby amended to read as follows:

26 "2. TERM. The term of this Agreement shall commence at midnight on
27 January 1, 2016, and shall terminate at 11:59 p.m. on December 31, 2019, unless sooner
28 terminated as provided in this Agreement, or unless the services or the Project is

1 completed sooner. The parties have the option to extend the term one (1) additional one-
2 year period.”

3 3. Except as expressly amended herein, all terms and conditions in
4 Agreement No. 34176 are ratified and confirmed and shall remain in full force and effect.
