Honorable Mayor, Council and Staff,

I work for the International Brotherhood of Electrical Workers (IBEW) Local 11 and the National Electrical Contractors Association (NECA) of Greater Los Angeles. This represents around 400 electrical contractors who partner with approximately 10,000 union electricians. I am writing to express our strong support for Item 23-0312, to deny the appeal of the Planning Commission's decision and approve two conditional use permits to operate trucking use at 1711 Harbor Avenue and 1515 W. 17th Street. Not only have these projects shown to have zero negative community or environmental, these also include EV charging stations and a green trucking business model. Moreover, these projects will create high-road careers. The developer, Cargomatic, is committed to workforce standards and partnering with union labor.

Projects with workforce standards like these lift communities. IBEW/NECA and the Los Angeles/Orange County Construction Trades work extensively with community groups like Anti-Recidivism Coalition, Women in Non-Traditional Employment Roles (WINTER), Helmets to Hardhats and many others to ensure equity and inclusion. IBEW/NECA has a dedicated outreach coordinator to work in communities to reach underrepresented populations.

Projects like these create a demand to recruit Apprentices. Apprenticeship programs are what transform temporary jobs into high-road careers. Students at IBEW/NECA's apprenticeship program do not pay for their industry-leading education. They earn wages while they learn. They receive excellent health and retirement benefits, and regular raises. When students graduate, they earn family sustaining wages and have the skills and knowledge to work on many project types across many facets of the electrical industry, career advancement opportunities and the ability to work in other regions of the country.
