WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspection services; and

WHEREAS, the parties entered Agreement No. 33819 whereby Consultant agreed to provide these Services; and

WHEREAS, the parties desire to increase the Agreement amount for a total not to exceed amount of \$155,000 for the entire term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

1. Section 1.A. of Agreement No. 33819 is hereby amended to read as follows:

"1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, an amount not to exceed One Hundred Fifty-Five Thousand Dollars (\$155,000), at the rates or charges shown in Exhibit "B"."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33819 are ratified and confirmed and shall remain in full
