4 CITY OF LONG BEACH DESIGNATING THE BALLOT
5 LISTING OF THE CANDIDATES WHICH HAVE BEEN
6 NOMINATED FOR THE CITY'S PRIMARY NOMINATING
7 ELECTION ON TUESDAY, JUNE 7, 2022

9 WHEREAS, in accordance with the Long Beach City Charter, the City
10 Council has called a municipal primary nominating election to be held in the City of Long
11 Beach on June 7, 2022, for the City Council offices in Council Districts One, Three, Five,
12 Seven, and Nine, and for the offices of Mayor, City Attorney, City Auditor, and City
13 Prosecutor; and

14 WHEREAS, in accordance with City Charter Section 1907, the City Clerk
15 has submitted to the City Council a certified list of the candidates which have been duly
16 nominated as required by law for the elective offices to be voted on at said election, and
17 the names are listed for each such office in the order of the randomized alphabet
18 selected by the Secretary of State in a drawing held on March 17, 2022, pursuant to
19 California Elections Code Section 13112;

20 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
21 follows:

22 Section 1. That the following list which has been regularly certified by the
23 City Clerk sets forth the candidates nominated as required by law for the offices shown
24 and is in the order of the randomized alphabet selected by the California Secretary of
