STUDY SESSION:

Conduct a study session to provide the applicant and staff with direction on the processing of a Certificate of Appropriateness request for exterior work that has been completed without any historic approval from the City on a contributing structure located at 21 Redondo Avenue in the Bluff Park Historic District. (District 3)

<u>DISCUSSION</u>

The subject of this study session is a proposal to review the conversion of a 1940 ranch style home to a modern Spanish style home. The property is located within the Bluff Park Historic District on the west side of Redondo Avenue adjacent to a 20-foot-wide east/west alley one lot north of Ocean Boulevard. While the site has a zoning designation of R-2-L (Two-family residential district with large lots), the property in question is quite small at 3,375 square feet (75 feet by 45 feet). The one-story stucco home with attached one-car garage was built in 1940. The home is classified as a contributing structure.

This ranch style home has a low-pitched roof which was covered with light gray composition shingles and one-car garage accessed off the alley. The home was clad in light gray stucco with black multipane wood sash windows bordered by a horizontal black band. A brick fireplace was located on the south elevation off the living room.

A stop work notice was issued March 31, 2011, when it was discovered that the exterior of the home had been altered without City approvals. The applicant obtained a permit that same day to remodel a kitchen and two bathrooms. A note was made on the building permit application that all work was located on the interior of the home and no exterior

changes were proposed on the issued permit. The exterior of the home has been completely altered. All previous exterior finish materials, windows, roof, front door, garage door and exterior light fixtures have been removed. The home has been restuccoed in a smooth hand trowel white finish and a red clay tile roof installed. The original windows have been replaced with brown vinyl windows. The front door and garage door have also been replaced. Lastly, a new stucco finish has been applied to the retaining wall at the front property line and on the brick chimney.

The study session is an opportunity for the applicant to present their proposal to the Cultural Heritage Commission and for the Commission to provide any comments and suggestions to the applicant and staff before the item is brought back for future consideration.
